### Narratives For Incident

#### Narrative :

On 10-03-2024 at 1100 hours, I responded to a cold Burglary call at 2200 East 104th Avenue at Suite #209, In the City of Thornton, County of Adams, State of Colorado.

Upon arrival, I spoke with Manager of the RJB Systems Incorporated, Tyler Moore (DOB 01-13-1991) at his office at Suite #209, I observed there to be damage done to the front door of Suite #209. Tyler told me that they, and neighboring offices had been broken into last night. Tyler and associates closed at 2000 hours last night and did not open until 0700 hours this morning. Tyler informed me that his office had been broken into and rummaged through with numerous electrical devices stolen. Tyler also informed me that he had no alarms nor cameras in his office that would have captured the suspect. The

stolen items from Tyler's office are as follows: a \$200 SPORT Speaker, a \$1000 Sony A6000 Camera and Lense, a \$100 Ace Hardware Tool set, and a \$200 Google Chromebook. The total amount of all items was estimated to be \$1500. Tyler said that when he and his staff arrived at work, he had manipulated the items to put them back in an orderly fashion, prior to my arrival.

I spoke with the Owner of Hispanic Marketing Solutions at Suite #208 in response to his business also having been broken into. I observed there to be damage done to the front door of Suite #208. He said that he had just gotten into the office after hearing that his neighbor's office had been broken into. He said that when he went to check in on his business, he noticed that all the doors were opened, and his items had been rummaged through. Johnathan said that this was not the state he had left his office in prior to leaving on Sunday, 09-29-2024 of last week. He only observed two of his \$780 microphones to have been missing. The total cost of all stolen items amounted to \$1560. Please see Case Number 2024014748 for further details regarding Suite #208.

I spoke with the Manager of Adam's Logistics in Suite #211 at 2200 East 104th Avenue: Martin and Alex. Martin was of the three office Suites that had been broken into. I observed there to be damage done to the front door of Suite #211. Martin said that a total of \$200 in miscellaneous items had been stolen. Alex said that the business closed around 2000 hours yesterday and Alex arrived to work today at 0645 hours. When Alex arrived to work this morning, he noticed there to be damages done to his door and items missing from his Suite. Alex said that the Eastern most entrance to the second floor the office building was unlocked. Alex said that this door is normally locked during non-operational hours. Please see Case Number 2024014752 for further details regarding Suite #211.

I read on a sign posted on the Eastern-most door referenced by Alex that reads: "Please keep this door locked after 5PM".

It should be noted that prior to my arrival, staff and workers of the aforementioned offices, had already started their work prior to my arrival. Doorknobs or merchandise that could have been touched by potential suspects, had been manipulated by staff prior to my arrival.

I surveyed the exterior and interior of the building that houses the three offices. There are no cameras on either the interior or the exterior of the building that would have captured this incident. I checked with every, opened, business on the Second floor of the 2200 East 104th building besides the aforementioned burglarized ones. Each business owner/manager informed me that they had not suspected a break-in into their office. Many of the office staff in adjacent rooms, voiced their frustration for the lack of surveillance equipment in the building.

I took photos of all of the damaged doors, and the East Entrance and uploaded the photos to Evidence.com.
